**Dates:** May 16, 2020 and EIC Match May 17, 2020

**Location:** Pedneau Range, Ft. Richardson, Alaska

**Sponsor:** Alaska Rifle Club

**Directions:** Traveling North from Anchorage exit the Glenn Highway at JBER-Richardson exit, turn right at top of ramp, immediately turn left at gate onto Frontage Road, go 2 miles and turn right onto the gravel road at the Small Arms Range Complex sign, turn right at Y and follow the signs to Pedneau Range (first range on left).

**Rules:** Current NRA High Power and CMP rules will govern.

**Eligibility:** Open to any ARC member. One- or 2-day memberships (\$5.00) are available for out of town competitors.

**Pre-Registration:** ALL competitors are required to pre-register beginning 2 weeks prior to the match, utilizing the link on the clubs' website. [www.akrifclub.com](http://www.akrifclub.com) . Walk-on participants may register on a space available, first come, first served basis.

**Registration Capacity and Fees:**

Please Note: **Schedules require that no late entries can be accepted.**

**Start Times:** Firing commences:  
Service Rifle Championship: **0900**, Saturday, May 16, 2020  
E.I.C. Leg Match: **0900**, Sunday, May 17, 2020

**Squadding:** All matches will be squadded. Squadding assignment for individual matches will be issued during registration. **NRA Membership numbers and classification cards, if competitor has them, must be exhibited before squadding tickets are issued.** A competitor who fails to present himself at the proper firing point when his relay is called may lose his right to compete in that event.

**Classification** The NRA classification system will be used in The Service Rifle Championship. Unclassified competitors will compete in the Master Class. Assigned Classification (Rule 19.6), or Temporary Classification (Rule 19.2), may be used when making an entry in an NRA Tournament. No classification applies to the EIC match however entry preference, if range limits are reached, will be given to non-distinguished competitors.

**Targets:** Unless noted elsewhere, 200 yards (SR target), 300 yards (SR-3 target), and 600 yards (MR-1 target). Competitors will be required to pull targets.

**Sighters:** Sighting shots (Rule 9.2.a.), which are allowed in the conditions for each match may be taken and recorded. Sighting shots may be taken in a position other than specified for the match but must be one of those described in Rule 5 of the High Power Rifle Rule Book, except 5.13. No sighting shots are allowed in the EIC match.

**Affidavit:** **The club will require a new CMP eligibility affidavit and liability agreement, that is Notarized, be submitted upon registration for the EIC match, IF YOU HAVE NOT PREVIOUSLY SUBMITTED ONE OF THESE TO THE CLUB IN THE PAST. **SAFETY:** Open bolt indicators, eye and ear protection required.

**Note: 1 – M-110 is allowed as a Service Rifle by the NRA, Rule 3.1(d), but not by the CMP for the EIC Leg Match.**

**Saturday, May 16, 2020**

**Rifles:** NRA Service Rifle-Rule 3.1, (a) (b) (c) & (d) .  
Metallic or Optical sights are authorized in accordance with the above rules.

**Match 1:** 2 sighting shots and 20 shots for record, standing, slow fire, 200 yards, SR target. (Rule 5.12)  
**Match 2:** 2 sighting shots and 20 shots for record, sitting or kneeling, rapid fire, 200 yards, SR target. (Rule 5.8 or 5.10)  
**Match 3:** 2 sighting shots and 20 shots for record, prone, rapid fire, 300 yards, SR-3 target. (Rule 5.6)  
**Match 4:** 2 sighting shots and 20 shots for record, prone, slow fire, 600 yards, MR-1 target. (Rule 5.6)  
**Match 5:** The slow fire aggregate: an aggregate of scores fired in matches 1 and 4  
**Match 6:** The rapid-fire aggregate: an aggregate of scores fired in matches 2 and 3  
**Match 7:** The Service Rifle Championship: an aggregate of scores from matches 1-4

**Classes:** In fired match will be the same as aggregate matches.

**Awards: Open Awards**

Awards will be issued per the NRA minimum award schedule for registered tournaments.

Winner: State Service Rifle Champion Award

2nd Place:

3rd Place:

An individual winning an open award (Winner, 2nd, or 3rd), may not win a category or class award in the tournament, but these individuals will be counted in determining the number of class awards.

**Class and Category Awards**

Awards will be issued per the NRA minimum award schedule for registered tournaments.

There must be 5 or more entries in a class for one award, 8 or more for two awards; and 13 or more for three awards. If there are fewer than 5 High Masters entered, they must fire for open awards only. The High Master Class may not be combined with the Master Class.

If there are fewer than the required number of entries in a class to provide awards, they will be combined with the same class in another category. If there are still fewer than 5 entries after combining all categories of a class, there will be **no awards** provided in that class, and all competitors in the lower class will be moved back to their respective category within the next higher class until there is a minimum of 5 competitors in the combined class.

Note: Monetary awards will be sent out at the end of the High-Power season.

**Alaska Rifle Club  
Excellence in Competition Match  
Sunday, May 17, 2020**

**Eligibility:** In accordance with CMP rule 2.0  
All CMP-sponsored or CMP-sanctioned matches are open to any individual or team that complies with these eligibility requirements. U. S. citizenship is not required to participate. Individual membership in the CMP or a sponsoring organization is not required to participate. No person who has been convicted of a Federal or State felony or any violation of Section 922 of Title 18, U. S. Code, is eligible to participate in any activity sponsored or sanctioned by the CMP.

Eligibility Affidavit Required Before an individual is permitted to participate in any CMP-sponsored or CMP sanctioned competition, the sponsoring club or the CMP Competitions Department shall have on file a notarized affidavit from that individual certifying that he/she:

- a) Has not been convicted of any Federal or State felony or violation of Section 922 of Title 18 United States Code, and
  - b) Is not a member of any organization that advocates the violent overthrow of the United States Government.
- Rule 9.2.1 and 9.2.2 apply for non-distinguished military and civilian competitors, respectively

**Open Individual Category:** Competitors may compete "OIC" per Rule 2.10, but will not be eligible for awards or EIC points.

**Rifles:** Firearms in Excellence-in-Competition "Leg" Matches must meet the provisions of Civilian Marksmanship Program Rule's 4.1. Inspection will include weighing triggers and visual inspection ensuring the rifle is in compliance with Rule's 4.2. of the above-mentioned regulation. Arms authorized for use in CMP approved Service Rifle Matches are as follows:  
**4.1.4 - U.S. Rifle caliber .30 M1** as issued by the U.S. Army; or a commercial equivalent of the same type and caliber; or either rifle if chambered for 7.62mm X 51mm NATO.  
**4.1.3 - U.S. Rifle caliber 7.62mm M14** as issued by the U.S. Army; or a commercial equivalent of the same type and caliber.  
**4.1.1 - U.S. Rifle Caliber 5.56mm M16 (M16A2 or M16A4)** as issued by the U.S. Army; or a commercial equivalent of the same type and caliber.  
**Note: There is a big change, by the CMP, in what is allowed as a M16 Service Rifle. All competitors should read the new CMP Rulebook to become aware of the changes.**

**Ammunition:** Competitors in Excellence-in-Competition matches are required to furnish their own ammunition. Ammunition used must be similar to that manufactured for and issued through the service components. Specific guidelines are as follows: Ammunition may be commercially manufactured, or handloads. Projectile will be a full metal jacket with a pointed tip. No flat tip or round nose. The projectile may have a "ballistic" hollow point such as that used in the current military M852 style, 7.62mm arsenal match round. These guidelines will apply to all authorized service rifle calibers, i.e., 7.62mm (.308), 5.56mm (.223), and caliber .30 (.30-06). There are no restrictions placed on bullet weight or muzzle velocity. The major item considered to be of paramount importance is safety. All ammunition must be safe to shoot. Remember safety is the responsibility of everyone. None of us wish to endanger ourselves or other competitors on the line.  
Note: Ammunition may be purchased from the Alaska Rifle Club.

**Course of Fire:**  
10 shots in 10 minutes, standing, slow fire, 200 yards, SR target  
10 shots in 60 seconds, **sitting or kneeling from standing**, rapid fire, 200 yards, SR target  
10 shots in 70 seconds, **prone from standing**, rapid fire, 300 yards, SR-3 target  
20 shots in 20 minutes, prone, slow fire, 600 yards, MR-1 target

**Note 1: No sighting shots are allowed at any position or distance.**

**Note 2: Competitor may fire from position for rapid fires, but their score will not count toward Distinguished. The score card will be verified if a competitor started from standing, or not, and any who fire from position may not fire until after the first standing competitor fires.**

**Targets:** Competitors will fire or pull targets as squadded.

**Awards:** EIC points will be earned and awarded in accordance with CMP rules 9.2.  
**Note:** An aggregate minimum score of 91% is required to earn EIC points.
